



## **TERMS AND CONDITIONS**

### **STFL Community Club Raffle 2024**

1. The Promoter is:

Southern Tasmanian Football League Inc (ABN 40154899631) of registered office address: North Hobart Oval, 1-5 Ryde Street North Hobart Tasmania 7001, Post Office Box 714 Glenorchy Tasmania 7010. The abovementioned will be hereafter jointly referred to as the 'Promoter.'

2. Employees and members of the Executive of the Promoter or their family members or anyone else connected in any way with the competition or helping to set up the competition shall not be permitted to enter the competition.

3. To enter the competition an entrant must purchase an entry ticket at the entry price of \$5.00 per ticket from a participating Southern Football League Men's (SFL) or Southern Football League Women's (SFLW) club.
